- Call to order at 7pm
- April minutes moved into record.

7:00pm Public comments

7:05pm Totem Lake connector

- Aaron McDonald, city engineer
- 50K vehicle trips per day at the 124th/124th intersection
- Four build options, to be decided by City Council in June
- \$12M overall budget, \$5M not yet funded; have applied for a grant that would fill it, may consider "naming rights" funding
- What do we want from Kirkland residents?
 - o Input! We've reached a fraction of the citizens
 - O Some people have said, "I didn't see a vote for this!" and that's true. The city is trying to get it all done with grants and possible private funding

7:25pm Marina Park Pier expansion concepts

- Ellen Miller-Wolfe and Brian Baker
- City asked marina users: "If there were more capacity, would you use it?" Answer: yes 87% said they would visit Kirkland more often
- Kirkland already has the largest amount of public moorage on the lake
- 86% of boats that moor are owned by non-Kirkland residents
- Each boat that moors represents \$150 average spending downtown
- Some Port of Seattle funding, plus a portion of moorage fees, has paid for the study and plan so far
- We have only one commercial berth, currently used by Argosy; commercial berths may be part of the expansion
- Marinas that have breakwaters (e.g., Carillon) get much more business so all of the proposed expansions include adding breakwaters
- Current plans and cost estimates do <u>not</u> include any "upland" improvements (more restrooms, parking, etc.)
- Open questions of how to manage the marina (city staff? contractor?) and how to set fees, arrange maintenance, etc.
- Options:
 - o 41 moorings (current capacity, unchanged)
 - o Alternative 1, keeping the old moorings:
 - Phase 1: 87 total moorings, \$15.4M
 - Phase 2: 120 total moorings, \$3.1M additional
 - Alternative 2, replacing the old moorings
 - Phase 1: 80 total moorings, \$14.9M
 - Phase 2: 122 total moorings, \$10.6M additional (still at inner harbor line, but demolishing/replacing the old moorings)
 - Alternative 3, replacing old moorings and expanding to a further-out "outer harbor line" (bigger footprint)
 - 180 total moorings, \$35.3M
 - Could be done as an extension to Alternative 2
 - Alternative 4, just adding a small-boat floating extension
 - Single phase: 41 total moorings (no change), \$600K
 - Benefit of adding a floating separate small-boat dock? Not stated.

- Staffing is low
 - o WA state has ~1,000 police job openings; 5 open in Redmond
 - Non-patrol staff has been assigned to patrol: K-9, traffic patrol, school resource officers
 - o 6 officers are in training, post-academy (riding with a senior officer)
 - o 1 is in academy
 - o 4 are in the pipeline to the academy
 - o 4 offers are outstanding to potential candidates
- #1 crime in Kirkland is car prowl; lock your car and secure valuables
- #1 criminal profile is a drug addict
- What can KAN and Kirkland residents do?

- o Call 911, including for non-emergency (or see next item)
- Use the online reporting system for non-emergency events; it's working well as information collection
- Continue hosting police at neighborhood meetings
