7:10pm Sustainability Master Plan

• David Barnes, Planning Department

Purpose

- Coordinate City's existing master plans
- o Help execute critical pieces of those plans as related to sustainability
- Help City staff make decisions about operations using sustainability as a lens
- Develop a clear implementation plan to help the community live better and thrive
- o Go beyond goals and policies, to implementation steps

Focus areas

- Energy supply and emissions
- o Buildings and infrastructure
- Land use and transportation
- Sustainable business
- o Sustainable materials management
- Natural environment and ecosystems
- Healthy community
- Sustainable governance

Process

- Community participation
 - Using the Themed Resident Engagement for Kirkland (TREK) process to involve business, community, and development groups, from May to end of summer 2019
 - Released a <u>survey</u> to community for input on focus areas and elements – available online through July 3
 - Video created for intro to public meetings
 - Included on City website
 - Sent out via social media

Sustainability Forum

- City Hall
- World Café format, with subject matter experts (SMEs) at each table
- Collect feedback on focus areas, elements, and action steps

Next steps

- Summer Farmers' Markets

- There are many groups working on sustainability in many forms, from schools to Microsoft

- Q&A
 - (Lisa) Suggest a Neighborhood Sustainability Program, like the Neighborhood Safety Program
 - Good way to engage community
 - Generate hyperlocal projects, action
 - Check some actions off, get momentum
 - (Leo) Alternative transportation methods
 - Need more protected bike lanes, alternative transportation support
 - Vehement discussion ensued on bike lanes and safety
 - Janet: see the recent article in the Seattle Times on what kinds of bike infrastructure are safe
 - O (Heather) How can we encourage and enforce responsible waste management?
 - Can we penalize people who don't recycle? Who's in charge?
 - David took down the comment; kids in school forums have also raised the point in reference to food waste
 - o (Heather) Bikes and scooter update?
 - David W. will address later
 - o (Neal Black) Portland shifted to 1x/2wks for trash pickup
 - Huge uproar for the first two weeks
 - Then everyone got used to it, and waste volume dropped greatly

7:50pm Proposition 1 and Community Policing

- Chief Harris, Kirkland Police
- o Reviewed the projects funded by Proposition 1, passed last year
 - Hired seven Prop 1 position officers
 - It takes roughly a year to get new hires through Academy and advanced training
 - The Academy is backlogged (lots of retirements, so everyone is hiring)
 - Hiring includes four women, two African-American men, two Hispanic men
 - Deploying/Assigning existing personnel to Prop 1 activities as well
 - Dedicated proactive police unit (ProAct Unit), August 2019
 - Administrative support assistant (ASA), August 2019
 - School resource officers (SROs), January 2020
 - Neighborhood resource officer (NRO), January 2020
 - Mental health professional (MHP) to be determined
 - Currently analyzing WASPC grant funding availability and King County MIDD funding
 - Gun Safety Program
- o Q&A
 - (Lisa) Anything to be done about mailbox vandalism and theft?
 - Federal attention only goes to organized criminal activity for this

- KPD gets lots of reports, circulate them (with videos/pictures, if available) to other agencies
- KPD prioritizes emergent, real-time crime and calls, so after-the-fact events get less priority
- (Bill) What can KAN do to help?
 - Pass on complaints/feedback from citizens to KPD
 - (Jim Lopez) There's a video that we're taking around the community to show what's being done and to collect feedback, input
- (Heather) How should people report disturbing/concerning things that appear on social media?
 - If it's an emergency, then 911
 - School resource officers attend PTA meetings; can contact them there
 - The KPD website has a method to file an anonymous report
- (Lisa) We do a lot of Neighborhood Safety work, spending lots of money on flashing beacons and such
 - But the onus of safety is always on the pedestrian/bicyclist (the vulnerable user)
 - How can we get more driver enforcement and education?
 - KPD is doing more "focus patrols" in key areas, based on crash data and such
 - People should report near misses, other concerns as these don't appear in crash data
 - O Go to the Online Reporting site and click "Tip Line: Suspicious Activity"
 - Can we get this functionality on the Our Kirkland site?

- o New map to show potential street developments throughout the City
- Online capability for people to submit comments
- o (Lisa) Is there space on the map to suggest bike/bus lanes?
 - Sure, we'll take all connection-related comments

7:05pm Car-Free Sundays

- Karen Story presenting
- Closing Park Lane on Sundays
- We've had two Sunday events so far, to mixed reviews
 - Businesses complain about loss of parking
 - Parking is not well advertised or marked (e.g., you can park in the garage Permit spaces for free on weekends!)
 - Businesses report that they lost revenue
- o Musicians have performed; we'd like to have more!
 - Jugglers, artists, etc.

- Games? Chalk zone for kids? Beanbag toss?
 - Somebody would need to own such a thing: setup, storage, teardown, etc.
 - Kirkland Parks offered to help with funding if someone wants to propose and own an activity
- Encourage people to come downtown on Sundays and enjoy the event, patronize the businesses
- Contact Karen if you have referrals for performers
- (Bea) Maybe offer business the opportunity to sponsor a Sunday? "Zeeks Owns the Street!"
- (Leo) If parking is keeping people from participating, that tells us that our alternative transportation is inadequate
- (Neal Black) Recent Kirkland Downtown Association meeting: many negative comments
 - Retailers complained
 - Lower client volume
 - Clientele less likely to buy, more out for the event and not to shop
 - Only one restauranteur was present (Café Rococo) reported that traffic was usual volume but with different clients
 - "ROAD CLOSED" sign was perceived as a turn-off; can there also be something welcoming, like a balloon arch or something?

 - o Report non-emergency issues, request services, and ask questions
 - Links to online police reporting, request a public record, contact City Council, etc.
 - o David did a live demo of reporting an issue
 - o (Amy Falcone) Can you submit anonymously?
 - Some reports <u>cannot</u> be anonymous; the follow-up prompts require contact info
 - You do have to type in a name/contact for all submissions, but many categories will not actually report your name (though it may still be discoverable if someone is knowledgeable and diligent in trying)
- Bike and scooter share
 - City Council approved a pilot program
 - But no bikeshare companies bid for the program
 - Feedback: the market for bikeshare has shifted (e.g., Lime is moving away from bikes)
 - Other companies want to expand their base elsewhere first
 - City Council has given staff the directive to <u>not</u> pursue scooter share at this time
