7:03pm Introduction

- Chair Aaron Jacobson called the meeting to order
- Round-the-horn introductions

7:08pm Public comments

- Jennifer Loy: Graphics at public comment at city meetings
 - Recommend that KAN take a position on the recent decision <u>not</u> to allow people at public comment to display graphics (slide shows, projected graphics)
 - Other speakers at meetings can show graphics, so it's inequitable to deny that capability to public speakers

7:10pm Non-profit compliance

- Bea Nahon presenting
 - <u>PowerPoint presentation</u>

- Charitable status
 - 501(c)3: Finn Hill only
 - \circ 501(c)4: All others
- 501(c)4 details
 - Contributions are not tax deductible
 - Businesses that donate goods or services can take a <u>business</u> deductions but not a <u>charitable</u> deduction
 - Income is tax exempt (when related to the exempt purpose)
 - Existing organizations are grandfathered, but new organizations would require a notification process and permission from the IRS
 - Political advocacy is allowed in limited ways
- Reporting responsibilities
 - Washington
 - Annual, \$20/year
 - Also: Combined Excise Tax return due April 15
 - Should have "active nonreporting status" to eliminate this requirement
 - o Federal
 - IRS Form 990N, due May 15 each year
 - No cost, all online
 - Can forfeit your 501(c)4 if you don't file!
 - o City of Kirkland
 - Annual business license; due date varies
 - \$5 annual fee for online processing through State Dept. of Revenue website
- FinCEN Corporate Transparency Act
 - New federal requirement to file for many small businesses
 - But don't worry! 501(c) organizations don't have to file it
- Revised Code of Washington (RCW) <u>24.03a</u> changes in 2021
 - May need to update your Neighborhood Association's Articles of Incorporation and bylaws
 - Look at your mission statement and the purpose of your Neighborhood Association
 - (Jim Lopez) The City isn't examining the NAs; assumes we're all OK
 - The City can only support you if you're within the law, so make sure you are!
 - Bea is investigating how to get a professional assessment for all of the NAs, establish good "hygiene" for the NA charters
 - Need to get a quote for what it will take to investigate and propose how to comply
 - Hoping to get a grant from the City to cover costs
 - If you know a law firm that works with non-profits and would be interested in bidding for this work, send them to Bea
 - If a NA wants to tackle the analysis themselves, there's no barrier to that ... but we'd like to have a concerted response

- Washington State website has a <u>non-profit handbook</u> available for download
- (Lisa) Perhaps we could do a workshop approach
 - (Susan) I think that could work
 - (Bea) Each NA board can have its own discussion on how to approach compliance with standards; it's not a KAN decision
 - This is actually a good opportunity to review the mission and purpose of each NA; it may have evolved

7:48pm KAN Policies and procedures

- Bea Nahon presenting
- History
 - KAN co-chairs have historically been KAN reps, NA chair, or NA cochair
 - Could continue in the KAN chair role even if their rep/NA role had lapsed
 - Our Guidelines and Policies do not specify who is eligible to be elected or re-elected
 - Should there be criteria?
- (Chris) I don't know that KAN officers need to be KAN reps. In fact, it may be better if the KAN officers don't also carry the load of being a KAN rep as well.
- (Susan) Sometimes we're short on people to fill roles, as when I am the chair and the KAN rep for my NA. Adding restrictions could complicate matters.
- (Ken) I don't know how KAN would change our own bylaws. We don't have a documented procedure ourselves.
- Recommendation:
 - Must be a Kirkland resident.
 - Must be on a NA board <u>or</u> appointed as a KAN rep; it conveys a basic involvement and understanding of the organizations.
 - A change in these qualifications (such as moving from one neighborhood to another) does not immediately disqualify a standing officer of KAN. They can serve out the remainder of the term. And they can stand for reelection.
- Bea will draft:
 - A red-lined (suggested change) policy for how we change KAN policies, for the next KAN meeting.
 - A suggested policy for electing KAN officers, given the feedback today.

8:00pm 2024 KAN survey

- Aaron Jacobson presenting
- Reviewed the survey, as reviewed online by KAN members since the last meeting
- If approved, Aaron will make 13 versions of the survey, one for each neighborhood
 - Each NA can add a preface to its version and then post through whatever communication channels they use (mailing list, Facebook, NextDoor, etc.)
 - \circ Results will be tabulated per neighborhood and provided to the NAs
 - Aaron will also generate a combined result for all of Kirkland

- Timeline: Anticipating 3 months duration
 - Accounts for NAs that alternate social and business meetings, get a fair opportunity to advertise and promote it
- Approval: unanimous approval of the survey and sending it out

 - Where to find all you need to know
 - Crime in your neighborhood
 - Land use and permit activity
 - o City capital projects
 - What's coming up at the next <u>Council meeting</u>

 - Not sure where to find what you're looking for?
 - Jim wants to collect and distribute a list with these and more, make it easily available
- Kraken at the Houghton Park & Ride
 - Seattle Kraken has contacted Kirkland about proposing an ice rink at the Houghton Park & Ride
 - They would build a \$45M facility at their expense; Kirkland would lease them the site for \$1/year, and then after 35-40 years Kirkland would get the facility outright for their own use of any kind
 - Discussion: This is a very early movement, nothing defined or decided. Need to consider all other potential uses of the space.
