#### Co-Chair Janet Pruitt convened the meeting at 7:08 pm.

After introductions we unanimously ratified the January meeting minutes.

#### **Public comments**

Jan Young. Concerned about traffic and growth, particularly with the redevelopment of the Houghton Everest neighborhood center and potential traffic on 108th. Worried that "mom and pop" shops will not be able to compete. Not enough green space. Does not want transit on the CKC. Her ask of KAN is that KAN "act as an important representative force in protecting our neighborhoods from unsustainable growth."

Sandy Helgeson. Worried about Houghton-Everest plan. Neighborhood center expansion will make it too big for neighborhood. Traffic is already at maximum—worries about congestion. Worried about losing Met Market and PCC.

Dave Asher. Nourishing Networks full for winter break; watch for spring break event soon.

Paula White. With a group called Kirkland Safe. Kirklandsafe.org. Worried about hate crimes and vulnerable people. Wants inclusiveness.

# KAN Meeting Minutes 2/8/17

Lieutenant Saloum of Kirkland Police wants to make sure leaders know a police officer is available to go to neighborhood meetings. Talked about crime mapping on the web.

# Planning Commission Work Program - Eric Shields (Planning Director)

- Eric reviewed the draft <u>Planning Department work plan</u>. Many projects are uncommitted due to staff resources, including neighborhood plan framework (template), some neighborhood plan updates, and sign code updates.
- Correction from Eric: Feb. 23 The Planning Commission will discuss work program priorities, voting at that time on their recommendation to Council. The Council will review and discuss that recommendation at its study meeting (jointly with the PC) on Tues., March 21. At that time, they'll give direction to staff and we'll bring back a final work program for the Council to adopt in April (probably April 4).
- KAN asked if there is a way to streamline the neighborhood plan process. Finn Hill plan
  probably won't work well as a template, as had been hoped. Let Janet know if you are
  interested in meeting with Eric to discuss how to streamline the process so we can make
  neighborhood plan template and updates happen.
- Some sign codes were not enforced while the code was being updated to be content neutral (legal requirement). Eric will ask Council for direction on how to proceed with recommencing enforcement.
- Karen Story asked that any KAN members who have an opinion about sign enforcement contact the Council Planning and Economic Development committee before their Monday meeting on Feb. 13: <u>DMarchione@kirklandwa.gov</u>, jarnold@kirklandwa.gov, psweet@kirklandwa.gov, and cc <u>EShields@kirklandwa.gov</u>.
- Karen reported that the sign code committee will be giving Eric a scope of recommendations in early April, so he can estimate staff resources. She does not think the scope will be large.
- Planning Department is working on a housing strategy plan, including affordable housing. Not a solution, but a narrowing of options to address problems. They are looking to form an advisory committee, not of experts, but community members who have interest. Let Janet know if you are interested.
- Planning Commission is reviewing citizen amendment requests Feb. 9. Already have some emailed comments. See <u>Planning Commission website</u> for more info.
