The January meeting minutes were updated and ratified.

Bea mentioned that Karen Lightfeldt from Juanita is no longer the KAN Rep.

Wetland and Stream Code Amendments – Teresa Swan

- The Wetlands and Stream Code Amendments are currently being updated. The codes were last update in 2002 and since then Ecology has updated the standards. The City needs to update and be in compliance by June or the State may withhold grants for Transportation and Parks.
- The City did a broad notice to property owners within 300 feet of a stream or wetland.
- They will have a briefing with the council on February 16th. The next Open House is on February 25th prior to the Planning Commission study session. The City encourages people to come to the meetings and they can speak at the beginning of the meetings. - Q: from page 1 of the KAN packet regarding the mitigation location, the “in-lieu” program and concerns that the program implies that someone can wipe out a wetland

and just pay a fee. A:They would limit that to reasonable use where they cannot build on the whole site.

- Q: "in lieu" seems to favor commercial properties aka commercial property would be able to afford that (versus residential). The question was asked: who makes the decision of who has the option of in lieu? A: The Planning Commission and the City Council. First, they want them to do the project onsite and then it would be a preference to have a project in the City.
- Comment: Lisa McConnell would like to see that developers have to show an extraordinary case and that the project can't move forward without losing the wetland and would like to see more prioritization that "in-lieu" is only an extraordinary circumstance.

Before each of the study sessions from 6-7 there will be open houses.

Parking Survey #2 - Solutions

There was a discussion the upcoming parking survey and to get some ideas for questions to be on the survey. The second survey is the companion to the Parking Impacts in the Neighborhoods survey recently completed. The next parking survey will be proposed solutions to the parking issues and how residents might feel about various solutions to their parking issue. Some ideas:

- People are parking in the bike lanes. Residents were upset when the City marked the lanes as no parking. Clarify bike lanes vs road shoulder markings.
- Painting corners for limiting parking too close to corners – improve sight lines
- Permit parking zones in City
 - Some concern expressed for cost of permits, comments favored free or low cost for residents
 - Consider programs such as Portland's where the permit \$ go back to neighborhood improvements
- Time limited parking (i.e. 2 or 4 hour parking limits) In particular this was brought up to limit transit/commuter parking in neighborhoods

- Parking limited to one side of the street, especially in residential areas where street width (with parked cars) is an issue.
- Local access only
- Improved enforcement solutions - awareness campaign like “if you call, here is what will happen after you call.”
- Improved transportation solutions, local transit service, etc.
- Brief description of possible Pros/Cons or consequences of solution should be included with the question

Neighborhood Services Report – Kari Page

- 80th Street Overlay project – water/sewer main project (116th to 132nd). The water/sewer project will start early spring and is estimated to be complete in the fall. NE 80th Street will be overlaid in 2017.
- Juanita Drive Corridor quick wins - \$1M in grant money. A design consultant has been hired to design the project and work with the public. Construction is anticipated to start later this year.
- Feb 17th 11 am is the 85th street celebration, at Honda Auxiliary lot.
- Planning department has to move a historic Trueblood house and are offering it up for free

- Plastic Bag ban begins March 1st – Kari recommends that staff come to the neighborhood meetings to explain implementation
- School walk routes – the Lake Washington School District would like to update the school walk routes. Kari thinks it is up to us to get the neighborhoods and PTSA together to do these updates.
