






Q7 Comments



- Barely
- Between the parked cars (which could open their door in path of bicyclists) and the bike lanes, the north and southbound vehicle traffic on LWB/Lake St is very cramped. The problem is that we do not have enough parking spaces in our condo and apartment complexes so residents are forced to park on the street. Also, this is an area that attracts many visitors and they park on the street, as well. For this reason, it would be impossible to limit parking to just one side of the street. If we started having future construction along the boulevard that provided sufficient parking on their own property, then eventually we might be able to reclaim some space and only allow parking on one side of the boulevard. The council seems to be making decisions that continually decrease the required parking. The recent "right sized parking study" was a sham. Then they said that they "increased" the parking but that was incorrect too. The decreased the parking requirement from what had been in the code previously. (They used careful words and trickery when they said they were providing "more" parking. It was more parking than the Right Sized Parking Study would suggest, but it was less than code had required in the past.)
- BUT the parking on Lakeview blocks my view when leaving ne 66th st and it can be quite difficult to manage the traffic getting out of my street. I think this is a real problem.
- If cars are parked on both sides of the street traffic is restricted
- One side has curb/gutter while the other does not. Several of the older homes on the South side of the street have been torn down with new construction underway.






- Garage is too small for two vehicles


Q12 Comments




Q14 Comments


Q15 Comments



- Car break-ins have increased.
- During the summer nights Kids park at the top of the hill to watch the sunset. Some are harmless, others do drugs and drink. These rowdy groups will do doughnuts in the couldesac and throw beer and liquor bottles into the driveways residents on the street. We have found garbage from their escapades that include used condoms, empty beer and booze bottles and fast food garbage. Sometimes they play their music really loud with the deep bass that seems to penetrate all structures. We have been forced to intervene and tell some kids that they are trespassing on private property when they get out of their car and start climbing on the rocks to get an even better view. This summer was better than last summer and I'm not sure why. Last summer we would wake up to smashed booze bottles in our driveway. What NOT a great way to wake up.
- I have seen all sorts of really dangerous driving maneuvers such as turning around mid-block when traffic is nearly stopped. I have seen numerous near-miss collisions between vehicles and other vehicles, pedestrians, bicyclists and other types of motorized or non-motorized transportation. Cars routinely park halfway into red zones which makes coming out of our driveway near impossible. There is no police enforcement. I have never seen ANYONE get a ticket. Also, even when cars are parked fully behind a red zone, the red painted area is not sufficiently large to provide the visibility needed to safely exit driveway.




- Entirely insufficient parking near downtown Kirkland or alternate solutions to transit visitors to downtown restaurants/pubs/stores.


Q17 Comments




- 4th of July and Christmas Ships at Houghton Beach.

- The library garage used to be a reliable source of parking but lately it has been full when there are events




Q21 Additional Comments

- New apartments at S Kirkland P&R are not enforcing residents to Not park in transit parking
- People taking up two spots when they don't need to. One car took up two pots a few weeks ago and the car didn't move for 3 weeks-
- shoppers do not come to Kirkland like they used to because there is limited street parking
- traffic getting into Kirkland during peak rush hour or events
- tThe buses for school come flying by to take a shortcut to get to Lakeview elementary. Also traffic comes flying by to take a shortcut when Lakeview Blvd is backed up. The buses are what is really annoying, they should know better.
- Who ever thought up the idea of having fractional parking spaces that are supposed to be shared by residents in condos / apartments should have their head examined. Parking spaces should be two per unit without extra spots. Please follow this real life example as I've talked to many from other condos and apartments and they have all agreed. When a condo or apartment assigns one parking space and residents have the ability to use one of the "fractional" parking spaces, there is generally abuse of the parking rules. Usually someone in the apartment / condo project is a parking space hog. Not only do they park a second car in the shared stalls, but they often park a third car in the shared stalls. This deprives others from being able to park a second car on-site. Even worse, this parking hog may park two personal cars in general spaces and leave his assigned parking space for his friends or visitors.
