






#### **Q7 Comments**



- I would like the city to remove the planting strip on the north side of NE 75th ST by the high school and allow parking there. The existing grass is not maintained, and it would help if our street had more parking
- If parking on the street happens it is in front of houses
- It is too wide for the parking it has. Nobody parks on the street and people drive their cars too fast on the wide open street.
- Oh, if only people would park their cars in the garage instead of on the street!
- Our street is narrower than standard width. We have lots of visibility problems at the intersection due to fences obstructing viewpoints. It is made worse by people parking on the sidewalks (half on sidewalk, half on the street), blocking the use of the sidewalk for pedestrians, and forcing them to walk on the narrow street, where cars cannot see them because of view obstructions. Very unsafe. The nearest cross street also has a bike lane and we are in a school zone.
- Parking is ambiguous on my street because the parking lane also functions as a bike lane.
- Parking on both sides, esp. near NE 85th St, causes traffic and pedestrian issues.
- Street is quiet enough it's fine without sidewalks. Would become narrow and possibly more dangerous with sidewalks as people maneuver cars in tight spaces and kids unload from minivans going to the park
- The most recent resurfacing was poorly done, and parking in the spots in front of select houses further deteriorates the surface edges.
- The owner of the house on the SW corner of 76th and 130 parks two cars within a few feet of the stop sign on 76th, which blocks the view of 130th if you are heading East on 76th. I have been almost hit head-on several times. I have called the City of Kirkland, and they tell me no parking is allowed within 30' of the stop sign, but they park there anyway. It is a hazard to park on either side of 76th at the 130th intersection because you can't see around the cars.
- There is lots of building going on and sometimes it's almost impossible to get through the cars/trucks.
- when cars park on both sides of the street, only one car can drive through (no room for two lanes of cars), which is dangerous because it's a two-lane street.








- 116th Ave sees overflow parking from the Houghton P&R on Husky game days, and streets around Lake Washington HS get overflow school parking during school days and athletic events.








- Husky football games-cars overflow the park n ride sometimes


#### Q13 Comments


#### Q14 Comments



- As the new BIG houses go in, the new people seem to park on the street. I do not
  want to see that happen to my street, but with current zoning and permit process it
  seems inevitable.
- Developers are continuing to tear down one house and put up 2-3 on the same space!
- If the trend continues to be in the direction of tearing down ramblers (even those that seem to be in perfectly good condition) and replacing them with much larger and much more expensive "mega" homes, it seems that the more wealthy owners of these homes have more vehicles some of which they seem to park on the street in spite of having more garages than most smaller homes.
- Kirkland is allowing added housing density in our neighborhood, and lots of subdivided lots even when it is below the minimum lot size of the zoning. There is not enough street area available, particularly on our extremely narrow street, to accommodate the added residents' cars. This is one reason people regularly park illegally on the sidewalks.
- More house are being built.
- More houses being built, more visitors
- Near 85th Street, which gets busier and busier.
- No space for new businesses to be built. No parking elsewhere.
- Park is good for play groups so I expect that to continue. Other parking on the street isn't too heavy because residents all have driveways to park in. No changes expected.
- People are finding it difficult to both live and work in Kirkland and will look to become renters
- Some lots are being subdivided in the nearby streets
- There are no zoning changes in the works that I'm aware of.




- 126th ave. N.E. seems to be a relatively problem free street.


#### Q16 Comments



- Because it seems much more than just likely that most survey respondents would consider the last 3 items above (having to do with Vehicle-pedestrian, Vehicle-Vehicle and Vehicle-bicycle conflicts) "the most severe, if it occurs on any residential street"?, I'm afraid the mistaken conclusion will be drawn that residents in every neighborhood are most concerned about these "conflicts" in their own neighborhood. In other words, I think responses to the items involving "Vehicle related conflict" will likely be used to promote the idea that resident survey respondents are in favor of implementing major changes in their own neighborhood regarding these three "vehicle conflict" areas when in fact they are just offering their opinion regarding the concern they have for people getting injured or even killed whenever and wherever people and vehicles have experienced the kind of conflicts described in the last 3 survey items. Because I think these items are substantially rife for misinterpretation and should not have been included in the survey in the way they were, I have decided not to check them at all.
- driving too fast on too wide empty street
- parking too close to the stop sign or corner, blocking visibility.
- Some strange wording on this question--requires subjective interpretation of "severe" and "conflict"; no frequency allowance (once a week vs continually all day).




- Called the city

- No resolution was ever achieved.
- parking enforcement. They said they would notify the owner. I don't know if the ever did, but the owner still parks several cars on the street blocking the view of oncoming traffic.
- Through the South Rose Hill Neighborhood Association. Some action was taken, e.g. striping the curb near mailboxes and driveways and striping the road, but cars still park on either side of the road, thus reducing the street to one lane where cars have to stagger driving through.
- We've talked to Kari Page several times about the parking on our street. We were given the right to paint certain areas red but nothing major was ever really done.
- Yes, I called parking enforcement once about cars of local residents repeatedly, over a long-term period, parking on the sidewalks, blocking pedestrians, in a NO PARKING zone, near an intersection with poor visibility and a bike lane, in a school zone. This is an accident waiting to happen and someone will get seriously injured or killed if the no parking is not enforced and the view obstruction (fence) on city property is not moved. The parking enforcement did come out and warn the resident. They followed up with me in person but honestly seemed annoyed with me that I would call to report a parking infraction. Not sure if they are trying to discourage residents from reporting situations like this that are unsafe, but I was made to feel like the "bad guy" for reporting it.




- Building new houses on 83rd and 131st.


#### **Q21** Additional Comments

- I work in Seattle and see the problems that car campers create in some neighborhoods. I don't want to see that happen in Kirkland, so if we don't already have one I would like to see a ban on car camping.
- Kirkland has plenty of parking, to the detriment of other street uses. In most places the streets are too wide, and people drive too fast. I would like to see street parking repurposed as rain gardens (in neighborhoods) or protected bike lanes (downtown and on arterials), and I would like the city to stop widening the narrow neighborhood streets we have.
- Making 3-hour lots pay by the hour in downtown Kirkland is a dumb decision, given the current parking situation. Appears like nothing more than a money grab.
