 Provides information for readiness, response and recovery for an all hazards approach

- The office works to increase the City's capabilities, empower the community to be prepared, and prepare employees.

 - o Pet preparedness?
 - Carly gave advice on having backup plans and food reserves
 - Evacuation: shelters may not accept animals. The City has anticipated the need to open a human and animal shelter.
 - o Ham radio training?
 - Currently pointing to online resources, the American Radio Relay League
 - Open to increased interest from residents, could spin up more resources
 - How to accommodate children who are at school during a disaster?
 - School districts have plans and support services. The City is willing to partner to support preparedness efforts!

7:32pm Northeast Recycling and Transfer Station (NERTS)

- Keleigh Sharp presenting
- Friends of Taylor Fields
 - Opposing the site selection and SEPA process for NERTS
- History
 - Promise for 30 years from King County to close the Houghton transfer station
 - o MOU that promised no expansion at the existing site
 - Many issues: pollution, traffic, waste spillage, rodent infestation, odors, etc.
- Site selection
 - O More than 100 8+ acre sites were available for investigation
 - o Only four moved forward, and 2 were in SRH/BT neighborhood
- Existing location
 - Hundreds of homes
 - Proposed storage of containers close to homes
- Location
 - The stated goals of the facility include moving the site out of residential areas, and serving the northeast area
 - The Houghton site does neither of these
- "No critical areas identified"
 - The surface water and ground water contain arsenic, vinyl chloride (carcinogens)
 - Disturbance of the site could spread contamination along the downhill flow path
- This facility should be sited in <u>industrial</u> zoning

- [Kruse] Been in our house since 1978, and the County has often represented their intention to close the station. You can smell the dump when you walk by it.
- O: Where's the city council on this?
 - o We haven't gotten much response.
- [Deirdre] Larry Toedtli, last month, introduced information that the city was purchasing the Houghton Park & Ride lot from Metro. That lot is now out of consideration for NERTS. But Redmond does not have a site under consideration. The fourth original site on Willows was never viable. There is suitable property in Redmond that King County already owns! Site selection has not been fair and transparent. They need to revisit the process, add more sites, and ensure that at least one is in Redmond.
- O: Who should one speak to about this?
 - o King County.
 - City Manager Kurt Triplett did write a letter insisting that the siting process should include a Redmond site.
- Q: Why is the county concentrating on Kirkland?

- Kirkland is continuing to issue residential development permitting around the Houghton site. There is constant truck flow and frequent speeding on 60th St.
- Jessica Greenway, the first SRH./BT NA president, talked about how the county had intended to create a site in Woodinville, but then the county suddenly sold that land and stopped that plan. No explanation.
- Getting the message out
 - Engage with Friends of Taylor Field
 - Need media coverage and publicity
- At annexation time, our Council said it would give us a louder voice in the region. Where is that louder voice now?
- [Jean] Alternative view: We in Kirkland are creating trash. If we want less trash impact, then make less trash. I am delighted to have a transfer station in a convenient location. The original plan to extend the existing station to the north looks to me like a reasonable plan. Maybe there should be another station in Redmond, but that doesn't mean that's a solution for Kirklanders.
- [Pierce] Expanding the Houghton site would greatly affect a friend of mine.
- [Abi Gupta] Kids walk on the roads where the large trucks roll. Woodinville has issued a strong statement opposing the Woodinville site. We haven't seen a similar statement from Kirkland.
- [Launa] Has there been a petition?
 - o [Keleigh] The petition didn't get far, so we engaged a lawyer.
 - We get a lot of response about why the Houghton location is a good site
- 21-day comment period is coming up
 - Perhaps KAN could submit an opinion about the transparency and fairness of the site selection process?
 - o [Bill] At the least, KAN can disseminate information

- [Sue] Why does KAN not take a position on issues that affect the neighborhoods?
 - o [Bill] My view: KAN disseminates information
 - o There's value in having discussion without taking a position
 - o Moss Bay is having a discussion of this at their next NA meeting
 - o KAN has had speakers on both sides at previous meetings
- What are next steps?
 - o Council has projected making a decision in July

- Future use of the Houghton Village property
 - The City has purchased the Houghton Village Shopping Center to support a variety of potential public purposes, such as affordable housing, school space, non-profit program space, arts and cultural space, and City recreational program space
 - The Council is considering the potential to create a master plan as allowed by the current zoning to create a five-story mixed use building to accomplish these public purposes
 - o One public meeting has been held
 - o Two upcoming small-group meetings: 3/14, 3/27
 - Register at the city site
 - The meetings will <u>not</u> be recorded; summations are presented in a memo to Council
 - Example from first meeting: concern for the aesthetic of the building (appearance), and community use of a facility ("third space" for community groups)
 - o Council has allotted two years to decide how to develop the property
 - The discussion can include interim uses of the property
 - We have a civic responsibility to design and manage public property
- [Bill] What's cooking in City Council?
 - These topics tonight—Houghton Village, Park Lane—are taking up a lot of consideration right now
